Objectives


- Cost-benefit analysis comparison for:

Table of Specifications

- Building square footage: 55,000 ft²
- Ground temperature 64° F
- Frost line approximately 18"
- Water going to radiator system needs to be at 120 °F

Building Heating Load

- 3 methods of calculation
 - Current fuel usage: 549 MBH
 - Hand Calculations: 594 MBH
 - eQUEST Model: 687 MBH
- Annual Heating Load (degree day method): 1435 MBtu


Geothermal Heat Pump

Components

- 1. Heat Exchangers
- 2. Pump/Compressor
- 3. Pipes and Fittings
- 4. Valve
- 5. Working Fluid
